

Liability Waiver for 5K for Gun Safety

I, _____, acknowledge that I am choosing to run in the Solebury School Teach2Serve 5K for Gun Safety or the Kids 1 mile Fun Run (circle which) on Sunday, Oct. 28.

I therefore willingly assume all responsibility for any damage and/or injury to myself and/or my personal property, which I may sustain while involved in this activity, as well as any subsequent medical costs or expenses.

In the event of injury, I understand that Solebury School has provided for my safety first aid kits, an athletic trainer, and employees certified in first aid and CPR. If I avail myself of these resources, I further certify that I will not hold them liable for any good faith efforts to treat any injuries. If I do not agree to this, I will refuse treatment and/or call 911.

I further understand that neither Solebury School nor Solebury School Teach2Serve members is responsible or liable for my personal effects and property and will not be responsible for the security of my personal items. I agree to hold Solebury School and Solebury School Teach2Serve harmless in the event of theft or loss resulting from any source or cause.

By my signature, for myself, my estate and my heirs, I release, discharge, indemnify and forever hold harmless Solebury School, their officers, agents, volunteers, and employees, from any and all causes of action arising from my participation in their volunteer activities.
